I, for myself and on behalf of my heirs, successors, assigns and personal representatives, HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS Kari Deimer Answer to Cancer Corporation, it's officers, directors, volunteers, officials, agents and/or employees, other participants, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (RELEASEES), from any and all claims, demands, losses, and liability arising out of or related to any INJURY, DISABILITY OR DEATH I may suffer, or loss of damage to person or property.
